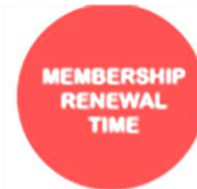

America's Newest Veterans' Memorial

A year ago in September (2024), America finally dedicated – in Washington DC – a national memorial to honor the veterans and the fallen of the First World War. It is a 60-foot-long, 38-figure, 20-ton bronze relief entitled "A Soldier's Journey," sculpted by Italian-American artist Sabin Howard.

The sculpture is striking, telling not only the story of an American soldier but also an American family. There are three main characters named The Father, The Mother, and The Daughter. On the far-left side, the Soldier's Journey begins; as his young daughter hands him his helmet, his solemn wife rests her hands on his shoulders. As the journey moves right, the Father is caught up in a tug-of-war as he joins a group of soldiers on the way to war, his wife reaching out to grab her husband for what could be a final time.

The continuing series of scenes portrays the agony, the wounded, the returned and the broken, and a victory as American soldiers parade across the battlefield, the American flag held high. This sculptural image creates uncommon emotional power that speaks in common to veterans of all wars, and tells those who serve today that 100 years from now, they, too, will be remembered."

On your next trip to DC, find this memorial in Pershing Park, a mere 150 yards southeast of the White House.

Legislative Report

New Laws for Thee and Me 2025 California State

- Number of bills introduced by state lawmakers in the past year: 2,350.
- Number of bills vetoed by Governor Newsom: 123.
- Number of bills signed by Governor Newsom: 794.

Here are several of the new laws.

SB-79 Housing development: transit-oriented development.

Overrides local zoning to allow high density 9 story apartment buildings adjacent to major rail, subway, and bus rapid transit stops. The height of the allowed apartment building gradually decreases with distance from the transit hub. A 4-story apartment building is allowed half a mile away. This law applies to 8 counties: San Diego, Orange, Los Angeles, San Francisco, Santa Clara, Alameda, San Mateo, and Sacramento.

AB-495 Family Preparedness Plan Act of 2025. Current law allows family members of a child to sign a caregiver's authorization affidavit. The affidavit allows them to enroll the child in school and authorize medical and dental care but does not grant them legal custody. This law broadens the definition of a "family member" raising child safety concerns. The intent of this law is to allow the children of illegal immigrants to be cared for even if their parents are detained or deported.

SB-627 Law enforcement: masks. This law bans law enforcement from wearing face masks to hide their identity. The intent is to make ICE agents more vulnerable to attack. The Trump administration has told federal law enforcement to ignore this law.

AB-867 Veterinary medicine: cat declawing. Makes cat declawing illegal in the state.

AB-1127 Firearms: converter pistols. Prohibits firearm dealers from selling any gun that can be easily converted into a fully automatic weapon. Opponents say that this law violates the Second Amendment and are suing the state.

SB-518 Descendants of enslaved persons: reparations. This law creates a state office called the Bureau for the Descendants of American Slavery. The purpose of this office is to determine whether someone is the descendant of a slave.

AB-715 Educational equity: discrimination: antisemitism prevention. This law establishes the Office of Civil Rights and the position of Antisemitism Prevention Coordinator to stamp out thought crimes in schools.

AB-1340 Transportation network company drivers: labor relations. Allows Lyft and Uber drivers to unionize.

SB-243 Companion chatbots. Law attempts to protect the mental health of minors during companion chatbot interactions by requiring a suicide prevention protocol, an explicit reminder that they are interacting with AI, encouragement to take breaks every 3 hours, and an avoidance of encouraging sexual content.

Phonics-Based Instruction is Back; When Did Phonics Leave the California Classroom?

Governor Gavin Newsom just signed Assembly Bill 1454 to bring phonics-based instruction back into elementary and middle schools. Assembly Bill 1454 was passed unanimously by both houses of the California Legislature, which speaks volumes.

Previous attempts to bring Phonics back have been opposed in the past by English language learner advocates, which claimed that a phonics-based approach only works for children who are fluent in English. And the state's largest teachers union, the California Teachers Association, opposed claiming teachers need flexibility to pick a reading program that works for their students, Calmatters reported. Because it's all about the teachers, rather than their clients – your kids and grandkids.

How did Democrats remove phonics and why are they now reinventing the wheel to bring it back?

Assembly Floor Analysis claims: "Prior to the pandemic, English language arts and English language development achievement in California was improving, and reading scores were approaching the national average," and "scores declined during the pandemic, and recovery remains slow." Baloney. Scores have been plummeting for years – since Phonics were discarded.

"It is a tragedy that California is only now going back to phonics-based reading instruction," Lance Izumi, senior director of the Center for Education at the Pacific Research Institute told the *Globe*. "We have known since the 1990s that the phonics-based science of reading is the most effective means of teaching reading. However, progressive educators pushed the failed balanced-literacy method of reading instruction that asked students to guess at words as opposed to sounding out letters to make words. Today, the vast majority of schools in California use this failed method. No wonder that only 28 percent of California eighth graders score at the proficient level on the national reading test. The bill signed by the governor is a welcome step in the right direction. The key now will be the level of implementation at the local level and whether the university schools of education will shift to teaching future teachers how to teach reading using phonics—a task that most have failed to do."

"More than half of California students taking the 2025 state English exam failed to score at the proficient level. On the state math test, more than six out of 10 test-takers failed to score at the proficient mark," Izumi reports.

In 1995, after state test results showed that the vast majority of California public school students could not read, write, or compute at levels considered proficient, it was evident there had been a wholesale abandonment of the basics of phonics and math drills in California classrooms, CATO reported in 2022. . . .

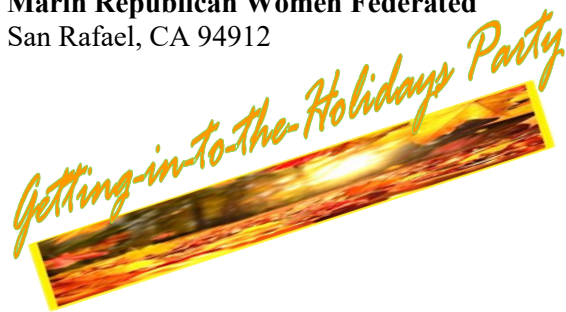

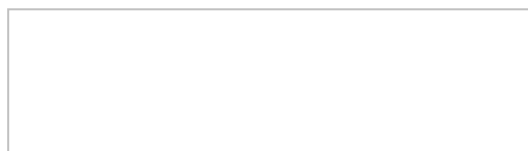
