VOTE NO on Prop 50!

On November 4th, there is a special election on Redistricting to change the U.S. Congressional districts in California. The districts are deliberately drawn to favor the Democrat candidates in district that are currently held by Republican Congressmen.

Let everyone know about this Statewide Special Election on November 4, 2025.

How to cast your vote – Vote in person: you will receive via U.S. Post a ballot in the second week of October. Leave this ballot at home. Wait until November 4th to cast your vote.. Walk-in to your local Vote Center, ask for a 'Vote Center Ballot', fill in your vote choice(s), and deposit your ballot in the ballot box that is inside the Vote Center.

How to get your vote counted on election night: this procedure will ensure that your ballot is counted on the night of November 4th and your vote will be in the vote totals on that day.

If you drop your ballot in any other 'ballot box' (e.g. a ballot box that is outside of the Vote Center), it will not get processed and counted until later in the month. Your MRWF members have been observing the Election processes for a number of years and have verified that this is exactly what happens to your ballot.

Across the U.S. people want a healthier way to eat, choosing beef as a source of protein, vitamins and minerals because it is a delicious food that is part of many cultural ways of eating. Science supports the flexibility to enjoy beef as the protein of choice and empowers Americans to choose beef, and sustainable dietary patterns. Imports are rising, South America is reshaping beef trade flows, Brazil and Uruguay are expanding their share of the U.S. beef market. Brazil's beef exports to the US will drop next month. Volumes could go from 30 thousand tons a month to just 7,000 tons. Brazil is a major supplier to the U.S. and tariffs will slow exports in the months ahead. Now ahead of Australia. Every January Brazil jumps out there because they are a big supplier. They fill that quota very quickly.

Although nearly 70% of Americans eat beef once per week, beef consumption has declined in at-risk populations, such as the disadvantaged, pregnant, young and aging, creating nutrient gaps and deficiencies. Nutrient-dense beef can help fill those gaps, providing iron, zinc, protein and B-vitamins. In addition, more than 65 percent of fresh beef cuts sold at the grocery store meet government guidelines for lean and consistently show that when beef is included in healthy dietary patterns, it supports cardiometabolic health and reduces the risk of chronic disease.

Gather with family and friends. Serve a delightful epicurean beef dish – like the Tri-tip we had for lunch in September or, even better, like the hamburgers being served at the October 4th picnic.

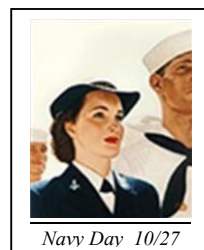

Legislative Report

AB-144 Health. Governor Newsom signed this bill into law on September 17, 2025, just 5 days after the state legislature amended a budget placeholder bill to bypass committee hearings and public comment. Both Assemblyman Damon Connolly and Senator Mike McGuire were complicit and voted for this bill. This law requires the State Department of Public Health currently run by Dr. Erica Pan (no relation to the notorious Dr. Richard Pan) to adopt the January 1, 2025, immunization recommendations of the United States Preventive Services Task Force (USPSTF), the Advisory Committee on Immunization Practices (ACIP), and the Health Resources and Services Administration (HRSA) and then to update them based on the recommendations of the American Academy of Pediatrics and other professional groups at their discretion. California has joined with Oregon, Washington, and Hawaii to form the Western State Health Alliance to counter any future CDC recommendation which might relax the immunization schedule. California currently has no personal belief or religious vaccine exemption and effectively no physician vaccine exemption for the required public and private school vaccinations. Amy Bohn of PERK is concerned about harm from the HPV vaccine to eighth graders and college students under the age of twenty-six. The state requires all schools to send a letter to sixth grade parents advising but not requiring them to comply with HPV vaccination recommendations prior to their child entering the eighth grade. The law also provides liability protection to those recommending and administering state required or recommended vaccines until January 1, 2030. This law guarantees freedom from liability indefinitely for those recommending and administering immunizations to minors.

SB-237 Oil spill prevention: gasoline specifications: suspension: California Environmental Quality Act: exemptions: County of Kern: transportation fuels assessment: coastal resources. Governor Brown in 2018 signed an executive order establishing the state goal of carbon neutrality by 2045. Democrat lawmakers have repeatedly attacked the oil industry but now are concerned about the political fallout of potential large spikes in gasoline prices when two oil refiners leave the state and state pipelines shut down due to decreased oil production. California produces only 23% of its oil consumption. The state imports the rest by ocean tankers and lacks the port infrastructure to import more. This new law allows Kern County to permit two thousand new oil wells a year during the next ten years, nullifying the lawsuits which have prevented further drilling. It also gives the governor discretion to decrease fuel standards if the fuel supply is inadequate, trading increased smog for lower fuel prices. State Senator Shannon Grove worked on this bill, but Democrats did not credit her as she is a member of the minority party. Of course, they also extended for twenty years the California cap and trade program

which funds their “climate” initiatives. Another bill signed by the governor allows the state to set up a Western regional energy market.

California’s Ministry of Truth: SB 771 is Gov. Newsom’s and Democrat’s Plan to Ban Speech They Hate

This isn’t California Democrats’ first rodeo – remember their 2018 attempt to create a ‘Fake News Advisory Council’.

California Governor Gavin Newsom and Democrats in the Legislature claim they want to regulate social media over hate speech. [Senate Bill 771](#) by Sen. Henry Stern (D-Los Angeles) claims this is about “Personal rights: liability: social media platforms.”

SB 771 is an “anti free speech” bill, comes entirely from California Democrats, and is designed to silence opposing opinions. The bill is not about moderating hate speech; it’s about banning speech Democrats hate.

This isn’t California Democrats’ first rodeo. In 2018, Democrat California lawmakers pushed legislation to create jack-boot agents of government through a “Fake News Advisory Council” – an Orwellian “Ministry of Truth” for the news they don’t like, [I reported](#). “After having my Capitol Press Credential [revoked in 2015](#) and only reissued after an Open Records Act request of 10-years of press credential applications, and viable threats of a First Amendment lawsuit, it appears Democrats in the California Legislature still don’t believe in [making no law abridging the freedom of speech, or of the press](#).”

That obviously stands today, 10 years later.

BUT WAIT! THERE’S MORE!

In April 2022, the Biden administration [announced](#) it had created the Disinformation Governance Board – its own Ministry of Truth – a part of the Department of Homeland Security.

Americans from all walks of life were horrified. Fortunately for the potential enemies of the state, the board’s executive director and disinformation czar Nina Jankowicz had already [becrowned herself in videos that went viral](#), demonstrating her stunning bias and partisanship. [Within three weeks](#) the Biden Disinformation Governance Board was shut down, and many Americans heaved a sigh of relief.

But not California Democrats.

...

Under **SB 771**, people will be fined if the State Censors determine that their social media posts constitute “Violence, intimidation, or coercion... based on race, religion, gender, sexual orientation, immigration status, or other protected characteristics.”

This feels suspiciously like what is taking place in the United Kingdom right now – people getting arrested and jailed for social media posts deemed by some government flak “intimidating,” “offensive” or “racially inappropriate.”
